PUBLIC HEARING ON 2022-2023 BUDGET:

ORDINANCE 2022-02:

Mayor stated he would not sign off on the agreement until we knew for sure our share would not be more than \$20,000. Allen Anderson made the motion to approve the agreement Joel Fingleman seconded the motion all were in favor to approve agreement once our part of the expense is confirmed.

After contacting Grantworks the next morning and them confirming our part of expenses would not exceed \$17000.00 Mayor Wells signed off on the agreement.

PROPERTY TAX:

This item was again tabled since an agreement on what and how the money would be spent could not be made. Further discussion on a later date needs to be had.

CLEANING OUT CIVIC CENTER:

Mayor said to find someone to do the work at a reasonable price and he would approve the city to pay for the work done.

BUILDING TEMPORARY OFFICE:

City Secretary will find a contractor to come in and build a temporary office, leaving enough area at the ceiling to allow for the return air to work properly.

FENCING:

Allen Anderson made the motion to get bids on having the center property fenced, seconded by Joel Fingleman, all in favor motion passed.
